Executive Board Meeting Minutes: September 18, 2024

New Business

Secretary-Treasurer Diana Tastad-Damer advised that Paul Cummings, a former UFCW 1189 member, is requesting the endorsement of UFCW 1189 for his election to the South St. Paul School Board. Nate Noel made a motion to endorse, Lee Cutler seconded. Motion passed.

Todd Gustafson made a motion to appoint Dean Nelson as the third trustee to UFCW 1189, Abby Czech seconded. Motion passed.

President Adam Evenstad advised that officer salaries, per the UFCW Constitution, requires consideration and approval by the UFCW 1189 Executive Board. Kim Levens made a motion to approve President Adam Evenstad and Secretary-Treasurer Diana Tastad-Damer's salaries and benefits; Curt Grad seconded. Motion passed.

All benefits are the same as the Field Staff bargaining unit. Auto expenses, phones and other expenses are to be reimbursed on the same terms as the OPEIU 12 collective bargaining agreement. President Evenstad is a participant in the National Pension Fund and UFCW 1189 Retail 401 a/k Plan. Secretary-Treasurer Tastad-Damer is a participant in the UFCW 1189 Retail 401 a/k Plan.

Abby Czech made a motion to approve \$225 in gift cards and up to \$1500 for food and beverages

for the Northern Division Membership Appreciation event. Todd Gustafson seconded; motion passed.

Old Business

UFCW 1189 member Wendy Felton requested the Board to consider participating and sponsoring a scholarship for South St. Paul High School. Todd Gustafson made a motion to decline participation due to UFCW 1189's Scholarship Fund and to notify Wendy of this action; Dustin Bru seconded. Motion passed.
