President Adam Evenstad reminded members of the Southern Division Membership Appreciation event taking place following this general membership meeting and deferred to staff for other reports.

Staff Reports

Union Representative Ray Gandy introduced new Servicing Representative Greg Neil and reported on immigration outreach to protect and prepare affected members in possible immigration raids.

Union Representative Deanna Hughes reported on current and recent negotiations based out of the Duluth office as well as the contract extension with ARGAs, the pending merger study evaluation between the Northern Retail and Southern health and welfare funds. The Duluth office is also working on pushing for contact information for those members. As part

of restructuring, Deanna is also working with staff on grievances.

Union Representative James Westin reported on current restructuring of bargaining and its process. Additionally, he reported on the several contracts successfully negotiated to date this year and the pending contracts being negotiated. The goals of the bargaining department include making contracts more reader-friendly, assuring contracts allow for progressive discipline, adding language to the grievance process, and upcoming implementation of MN Paid Family Medical Leave and current contract language.

New Business

A member inquired on the current status of unresolved retail negotiations with UFCW 663. President Evenstad pledged UFCW 1189's support of our Union siblings.

Secretary-Treasurer Diana Tastad-Damer advised that UFCW 1189 will be marching with the Minnesota AFL-CIO on June 29, 2025 during Pride celebration. Members interested in participating should contact Diana.
